1 I, Gregory T. Casamento, declare:

2 1. I am an attorney at the law firm of Locke Lord Bissell & Liddell LLP, counsel of  
3 record for plaintiff Sedgwick Claims Management Services, Inc. ("Sedgwick"). I have personal
